He had been looking into a members only portion but the complexity and receiving each member's approval would be difficult and time consuming. As the only thing that would be placed on it would be Members names and contact information it was decided not to persue a "Members only" section.

- New Business: John Long reported he had sent and email about the tattered flag over the Kensington Park Hotel that could be seen from the MMC & H. and asked the attendee's to follow up with emails of their own and passed out contact for that hotel. *
